Director of Education (Distt.) equivalent to 3 months salary of staff or Rupees One lakh + Rs 80/- per student within 3 months from the date of issue of letter.

- 8. That in no case the school funds will be diverted/ transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.

- 12. Salary & other facilities to staff and teachers will be made as per section 10(1) of DSEAR 1973 and relevant section of RTE Act, 2009.
- 13. Salary to the staff should be made through crossed cheque/ Electronic clearance system.
- 14. That the school shall provide free and compulsory education to the children as per notification no. 15(172)/ DE/Act/2010/69 dated 7/1/2011.
- 15. That the annual return Under rule 180 of DSEA&R, 1973 shall be filled with the concerned E.O.
- 16. That the school abide by the instructions/orders regarding fee-hike, issued by the Dte. of Education.
- 17. In case of Provisinal Recognition to the school situated in Non Conforming Area, the recognition will be subject to the outcome of notification by Ministry of Urban Development Govt. of India, Delhi.
- 18. That the violation of any instructions/order/rules and regulations of the department, shall lead to the withdrawal of recognition of the school.
- 19. Final outcome of the notification of MoUD, Govt. of India.
- 20. That the school shall provide the benefits of Bonus, Medical, LTC, Pension, Gratuity etc. given under Section 10(1) of DSEA&R, 1973 relevant section of RTE Act, 2009 to all the staff within 30 days.
- 21. That the violation of any circular/instructions/order/rules and regulations of the department, shall lead to the withdrawal of recognition of the school.
- 22. That the school shall appoint the 2nd special educator within 02 months and submit the requisite documents to the District Authority.
- 23. That the school shall comply with clause 14 of order no. F.DE/15(56)/ACT/2009/778 dated 11/02/2009 in r/o maintenance of DRF, School shall also ensure to follow FN-21 "Accounting by schools" as issued by the Institute of Charted Accountants of India (ICAI) for proper accounting treatment.
- 24. That the school shall comply with the orders dated 07.11.2017/guidelines of DoE and judicial pronouncement w.r.t. safety of students and shall take all necessary steps to this effect.
